### WAIVER, RELEASE OF LIABILITY, CONSENT TO MEDICAL ATTENTION, AUTHORIZATIONS AND CERTIFICATIONS

<p>In exchange for my being allowed to participate in the New Jersey FFA Career Development Event program, a program administered by the New Jersey FFA Association (NJFFA), I, and if I am not 21 years old, my parent or legal guardian (individually and collectively referred to below in the first person singular) agree to be bound by the following:</p> <ol style="list-style-type: none"> <li>1. Voluntary Participation: I understand and confirm that my participation in the Program is voluntary.</li> <li>2. Identification of Risks. I understand that NJFFA and its representatives may not be present during my participation in the Program. I understand that my participation in the Program may involve risk of injury and loss, both to person and to property. I also understand that the risk of injury may include the possibility of permanent disability and death.</li> <li>3. Assumption of Risk. I assume all risks, known and unknown, foreseeable and unforeseeable, in any way connected with my participation in the Program. I accept personal responsibility for any liability, injury, loss or damage in any way connected with my participation in the Program.</li> <li>4. Release and Waiver. I release NJFFA and its directors, officers, employees, agents, volunteers, successors, and assigns from any and all liability for and waive any and all claims for injury, loss, or damage, including attorneys' fees, in any way connected with my participation in the Program (a "Claim"), whether or not caused in the whole or part by the negligence (but not the gross negligence) of NJFFA or any of the individuals mentioned above.</li> <li>5. Consent to Medical Treatment. I authorize NJFFA to provide to me, through medical personnel of its choice, customary medical assistance, transportation, and emergency medical services. This consent does not impose a duty upon NJFFA to provide such assistance, transportation, or services.</li> <li>6. Publication.
